P00006 EXERCISE OPTION PERIOD

1. The purpose of this modification is to exercise the first option under contract N00033-08-C-2004 and incorporate FAR Part 52.232-19 (Incremental Funding Clause) into Contract Section I.
2. This modification constitutes written notice to extend the term of the contract as required by Contract Section I (Contract Clauses) MSC 5252.217-9806 Option to Extend the Term of the Contract - ALT I (DEC 2005) and FAR Part 17.207(a).
3. In accordance with modification P00005 which incorporated the revised Wage Rate Determination, charter hire rate for the M/V C-COMMANDO during the option period is (b)(4) per diem.
4. The period of performance for Option Period 1 crosses fiscal years and will not be fully funded at the time of award. The 92 days of performance occurring in FY 09 (01 JULY – 29 SEPTEMBER 2009) will be fully funded by (b)(4) at the per diem rate established by P00005 for a total value of (b)(4). The remainder of days occurring in FY10 (01 OCTOBER -31 DECEMBER 2009) will be funded subject to the availability of funds in accordance with Section I of the contract (FAR 52.232-18 & 19).
5. The parties hereby agree that the change in terms and conditions of the contract set forth above provide the parties with the full and complete adjustment to which each is entitled for the changes to the contract set forth above. The parties hereby waive all rights, title, and interest, if any, to further adjustment.
6. All other terms and conditions remain unchanged and in full force and effect.
