The following have been added by full text:

P00004 - EXERCISE OPTION ONE

The purpose of this modification is to exercise Option Period One of Contract N00033-10-C-2001.

1. Option Period One of Contract N00033-10-C-2001 is hereby exercised.
2. This option is exercised in accordance with contract Section I (Contract Clauses), MSC 5252.217-9806 Option to Extend the Term of the Contract - ALT I (DEC 2005).
3. Option Period One commences 01 October 2010 and expires 30 September 2011.
4. In accordance with FAR clause 52.222-43, which is incorporated into contract Section I, the contractor is required to inform the contracting officer within 30 days if there was an increase in wage rates due to the new Wage Determination, and, if there is, the amount of that increase. When and if such notice is received the contract will be modified to increase the price to reflect such changes.
5. The total cost of this contract was increased by (b)(4) (CLIN 0003 – Charter Hire) and (b)(4) (CLIN 0004 – Reimbursable Elements) for a total increase of (b)(4) from (b)(4) (b)(4).
6. In accordance with the clause of the contract FAR 52.232-18 AVAILABILITY OF FUNDS, which is incorporated into contract Section I, this modification is issued subject to the availability of funds. Funds are not presently available for this extension. The Government's obligation under this contract is contingent upon the availability of appropriated funds, from which payment for contract performance can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for this contract extension.
7. All other terms and conditions remain unchanged.
