MODIFICATION BODY

The purpose of this modification is to exercise Option Period Two of Contract N00033-10-C-2001. Accordingly,

1. Option Period Two is hereby exercised.
2. This option is exercised in accordance with Section I (Contract Clauses), MSC 5252.217-9806 Option to Extend the Term of the Contract – Alt I (DEC 2005).
3. Option Period Two commences 01 October 2011 and expires 30 September 2012.
4. The total cost of the Contract is hereby increased by (b) (4) for Charter Hire (CLIN 0005) and (b) (4) for reimbursable elements (CLIN 0006), for a total increase of (b) (4) from \$(b) (4).
5. In accordance with FAR 52.232-18 AVAILABILITY OF FUNDS (APR 1984), which is incorporated into Section I, this option is exercised subject to the availability of funding. Funds are not presently available for this extension. The Government's obligation under this contract is contingent upon the availability of appropriated funds, from which payment for contract performance can be made. In accordance with contract clause FAR 52.232-18, Availability of Funds, the Contracting Officer will provide the Contractor written notice via email or other method determined to be acceptable by the Contracting Officer when funds are made available.
6. Revised Service Contract Act Wage Determinations are hereby incorporated into the Contract as follows:
 - a. Attachment F (SCA WD 1994-0196 (Revisions 23 & 24)) is hereby deleted from the Contract.
 - b. SCA WD 2010-0116 (Revision 2) is hereby incorporated as Attachment F-1 (see attached).
 - c. SCA WD 2010-0147 (Revision 1) is hereby incorporated as Attachment F-2 (see attached).
 - d. SCA WD 2010-0148 (Revision 1) is hereby incorporated as Attachment F-3 (see attached).

In accordance with FAR Clause 52.222-43, which is incorporated into Section I, the Contractor is required to inform the Contracting Officer within 30 days if there was an increase in wage rates due to the new Wage Determination, and, if there was, the amount of that increase. When and if such notice is received the Contract will be modified to increase the price to reflect such changes.

7. All other terms and conditions remain unchanged and in full force and effect.
