

Objective

The contractor shall perform activities in support of the MSC Enterprise Data Warehouse (EDW) Maintenance in accordance with section C4.2 of the base contract. This support includes the impact analysis, design, development, testing and execution of system change requests for correction of system problems requested to the EDW baseline by the MSC Government Program Manager (PM). The support personnel shall respond to user questions resulting from MSC Global HelpDesk (GHD) Tier II and Tier III inquiries and provide guidance on proper system process user interaction. The support also includes developing changes to custom reports and interfaces necessitated by customer processing and review.

Background
